Petitioner, Sarah Gray requests the court enter an order authorizing the hiring of attorney Stanley R. Parrish of The Office of Stanley R. Parrish to represent the interests of the estate in a litigation brought by Sara Gray as personal representative of the Estate so that Extraordinary Fees may be authorized by the Court at the appropriate time and to authorize or ratify payment of a retainer from the Estate.

Petitioner was appointed Administrator and Letters issued on July 10, 2023. One of the estate's assets is a piece of real property in Placerville, which was destroyed in a fire and killed the decedent. Petitioner has brought litigation against the fire insurance company, after retaining Mr. Parrish to represent her and the estate, and paying a \$7,500.00 retainer. Petitioner paid the retainer from estate funds.

Petitioner requests that the Court authorize or ratify the \$7,500 payment of retainer to attorney Parrish for reasons set forth in this Petition. Petitioner acknowledges that litigation expenses, including attorney fees paid to be paid to Mr. Parrish are Extraordinary Fees within the meaning of Probate Code Section 10811 (b). As such, Petitioner is informed and believes that notwithstanding the terms of the fee agreement referenced in Exhibit B, that no additional fees can be paid by the Estate to Mr. Parrish in the absence of an order issued by this Court authorizing payment of attorneys' fees and costs pursuant to Probate Code Section 10830, 10831 or 10832.

Attachment 11 contains the legal description and APN of the real property. Petitioner is claiming 100% of decedent's 1/2 ownership of the property, per the terms of decedent's Will.

Decedent is survived by four adult children. Attachment 14 contains the names, relationships to decedent, ages, and residence/mailling addresses, as far as known to or reasonably ascertainable by petitioner, of all persons named or checked in items 1, 9, and 10, all other persons who may be entitled to inherit decedent's property in the absence of a will, and all persons designated in the will to receive any property.
